ODISSEI Privacy Statement

The privacy statement informs you of which personal data ODISSEI processes and how you can exercise your privacy rights.

Who we are

ODISSEI (Open Data Infrastructure for Social Science and Economic Innovations) is a consortium of member organisations for the development of a social science data infrastructure.

The consortium leader of ODISSEI is the **Erasmus University Rotterdam** (EUR), currently with project manager Lucas van der Meer MSc. The privacy regulations of the EUR apply for the activities of this project. The EUR handles personal data with care and acts within the limits of the General Data Protection Regulation (GDPR). The purpose of this website

The ODISSEI website provides information on the facilities that are supported by ODISSEI. It is also possible for you to register via the website for different events and the newsletter, among other things. As shown in the ODISSEI <u>Conditions of Use</u>, ODISSEI is not the owner of any research data.

What are personal data?

The GDPR states that personal data refers to all information on an identified or identifiable natural person. This means that the information either refers directly to someone or can be traced back to that person.

Indicators that ensure that information can be traced back to you include, for example, your name, your e-mail address and your IP address.

Why do we process personal data and whose personal data do we process?

Legal grounds

ODISSEI processes personal data on the basis of consent or a legitimate interest.

Consent given for the use of personal data can always be withdrawn again later. Objections may be filed against processing of data on the grounds of a legitimate interest.

Sharing data with third parties

The personal data gathered by ODISSEI are not shared with third parties unless this is necessary in order to realise the processing objectives. A business e-mail address may occasionally be shared on request, since this contributes to the network objective of ODISSEI.

For how long is data kept?

The personal data are not kept for longer than is necessary to realise the objectives for which the data were gathered.

Access to, rectification or erasure of data?

You may address an access, rectification or erasure request at any time to the Data Protection Office of ODISSEI by sending an e-mail to dpo@odissei-data.nl. In all cases, clearly state that this concerns a request on the basis of the GDPR.

In all cases, you will receive a reply within one (1) month of the receipt of a submitted request.

Technical and organisational security of personal data

Within ODISSEI, we treat the personal data gathered as confidential. We do this through appropriate technical and organisational security measures. To provide optimal protection against unauthorised access or use, all personal data are kept at a secured location.
